If he/she observes any unusual or significant hazard during his/her presence or participation, he/she will remove himself/herself from participation and bring such hazard to the attention of the nearest representative immediately; and
- (4) To release and hold harmless Oceanside Ice Arena Inc. and their officers, instructors, agents, and/or employees, other participants, sponsoring agencies, advertisers, and if applicable, owners and lessors of the premises used to conduct the event (collectively referred to as "releasees"), with respect to any and all injury, disability, death, or loss or damage to person or personal property, whether arising from the negligence of the releasees or otherwise; and
- (5) That this waiver applies to the undersigned, as well his/her heirs, devisees, assigns, personal representatives, guardians, conservators, administrators, agents, next of kin, and successors-in-interest.
